Building Updates

Work on the roof has begun and they are keeping Keisha updated with progress. The fire alarm and sprinkler system is currently being worked on and the anticipated completion date is the week of April 24th. Testing should be done on the 27th and the 28th to give us the all clear so that it can be certified. Strobe lights and sound had to be added to the new offices. The week of June 12th we are looking at the HVAC repairs being completed. The General contractor will come out and patch up any holes that were made by any move in operations. After that is complete the General contractor will then need to test the building for the areas where the roof was leaking to make sure we don't have any mold or mildew. We have the tentative approval from the Pharmacy Board for Arrowhead Pharmacy to move in. 97% of the offices are completed with furniture. Once roof has been cleared it will allow for work in the clinic area and Environmental Health to be completed and will also allow for the preparation for occupancy. Grand opening is still scheduled for July 1.

Dr. Obasanjo


It has been COVID-19 nonstop since the beginning of March. Janna gave update on testing and results. The numbers are 462 positives with 13 deaths. The outbreak, the vast majority of the effect is in nursing homes. We had two nursing homes tested. Swabbed 114 so far between the two nursing homes with the Chief and EMA's. Brad Smith one of our Environmentalist received his Certification in Public Health. Ola Adewale our Epidemiologist received her PHD.
